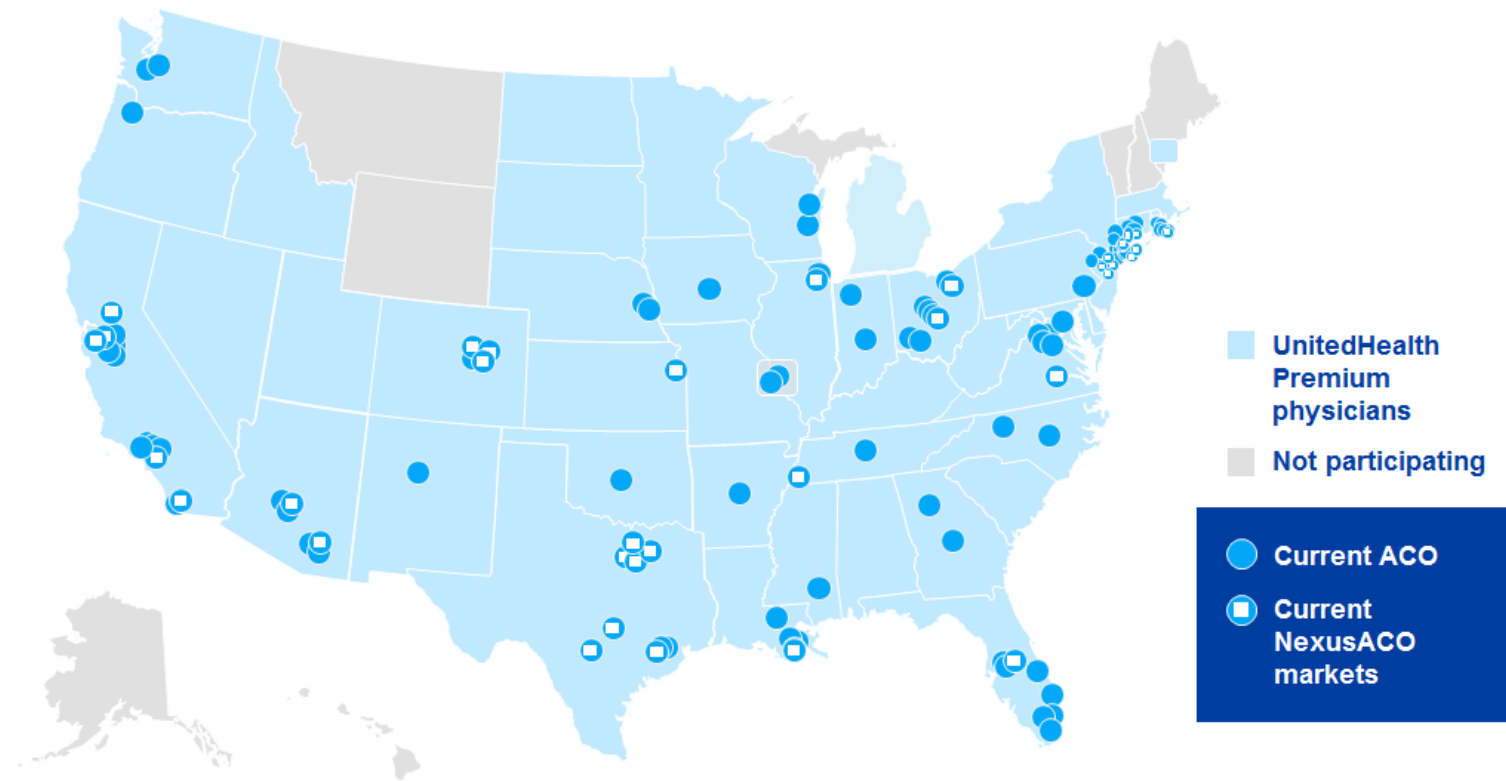


# NexusACO provides a national, tiered product offering.
